QUALIFICATIONS:

- Items for resale are not considered Arts & Crafts. Only 70%+ handmade products will be considered for Art and Craft Vendor Booths (please see definition attached).
- Vendors should provide an adequate description of their product. **At least 2 pictures, sample of work, or website address where work can be viewed are required to be included with this application for judging.**
- The event reserves the right to reject applications that do not meet the standard as judged by our committee. This would be for work that is of poor quality, inappropriate, or deemed to be manufactured commercially. Our goal is to provide a quality experience for the vendor and patrons. Rejected applications will be returned with payment.

BOOTH SPACES:

- Limited booth spaces are available in the HSNA Art & Craft section (120 total). Spaces are available on a first come basis after judging.
- HSNA Art & Craft vendor booth space (10 X 10) is \$35.00 EARLY ENTRY and a donated item for HSNA Opportunity Drawing. AFTER February 1, 2022, fee is \$50.00 and a donated item for the HSNA Opportunity Drawing.
- Electricity is not available.
- We highly encourage you to demonstrate your craft during the event.
- All vendors should supply their own tables, chairs, and tents.

TAXES: Vendors are responsible for collecting and reporting SC sales tax as required by law [MyDORWAY \(sc.gov\)](http://MyDORWAY.sc.gov)

Application deadline is March 15, 2022. We will accept applications until booth spaces are filled.

****Judging for booth spaces will take place once a month until spaces are full.***

Vendors will be notified of application status within two (2) weeks of submission.

NO APPLICATION WILL BE ACCEPTED WITHOUT THE COMPLETED FORM, EXAMPLES, & FEE.

Approved vendors will be e-mailed a welcome packet (no later than April 10, 2022)

including a map with their booth location, parking pass, and vendor guidelines.

***Break Down: 4:00pm-6:00pm**

***Vendors are asked to remain open until the official break down period or be subject to application rejection for future HSNA events.**
