You are invited to apply for a booth space for Heart of Sumter’s Art in the Park 2022. The event’s setting in historic Memorial Park (old Hampton Park) provides a beautiful and unique venue for patrons and vendors alike.

HSNA’s Art in the Park 2022 is a non-profit event with proceeds, such as vendor booth fees, going toward sustainment of the festival and toward support of local SUMTER and SHAW AFB nonprofit organizations. Attached you will find booth specifications, event guidelines, and the application to participate.

501c/approved & nonprofit organizations will **not** be charged food vendor fees and will keep 100% of their sales.

Space will be awarded on a first-come, first-served basis before the deadline of March 15, 2022. Each food vendor can sell up to two food items subject to approval by the HSNA Art in the Park Committee (food vendors will not sell beverages). In addition, we will offer the following to our food vendors:

- Listing of all food vendors on our HSNA’s Art in the Park 2022 Facebook Page along with a link to your website to share your mission and events.
- Additional advertising (print, radio and social media).

With space for **100+** art/craft and food vendors, we expect to draw a large crowd from Sumter, elsewhere in South Carolina, and beyond.

As noted above, the deadline to apply to become a FOOD VENDOR is March 15, 2022. If you need more information upon review of the materials, feel free to contact HSNA via email at SumterHSNA@gmail.com.

The **Children’s Craft Center** booths are available to be ran by a nonprofit or for profit organization(s) and shall be a 'no fee' booth (donations may be received for the "sponsored nonprofit" /mission). Each of these booths provide crafts for children to complete and take home.

Rules and Regulations

- Community FOOD booths are only available to the following organizations:
 - Churches
 - Non-Profits (must provide copy of 501c status)
 - Military Organizations
 - Health/Wellness Organizations
 - Public Schools
- Community booth space fee is FREE
- Community food booth spaces are 15X15
- First come-first served.
- Electricity is not available.
- Tents/Tables/Chairs WILL NOT be provided to community booths; however, vendors are encouraged to bring their own.
- Only two food items to be sold per community booth. (Example: 1. hot dogs & 2. chips.)
- All beverages, including water will be sold ONLY by HSNA
- All food vendors must review and comply with SC DHEC Food Safety Regulations 61-25. Please print and read!

- Children's Craft Booth(s) will be a "no fee" booth (donations may be received for the sponsored nonprofit / mission. And all funds received must be reported to Chair, Cleo Klopfleisch at SumterHSNA@gmail.com no later than 4/30/2022.

Vendors are expected to remain open until the official break down period. Closing early can result in an application rejection for future HSNA events.

Application deadline is March 15th, 2022 or until booth spaces are filled
